

## SECTION 00030 - NOTICE INVITING BIDS

RECEIPT OF BIDS: Sealed Bids will be received at the office of the South Valley Water Reclamation Facility; OWNER of the WORK located at 7495 South 1300 West, West Jordan, Utah 84084, until 2:00 PM on June 20, 2017, for construction of "South Valley Water Reclamation Facility – 2017 Biofilter Bark Addition". Any Bids received after the specified time and date will not be considered.

OPENING OF BIDS: The Bids will be publicly opened and read at 2:00 PM, June 20, 2017, at the above-mentioned office of the OWNER.

COMPLETION OF WORK: The WORK shall be completed as described below:

- a) Contractor shall:
  1. Furnish, screen and process, and place Douglas Fir bark in two biofilters
  2. Collect fine material from the onsite screening process and place it in the wedge zone around the perimeter of each biofilter.
  3. Preserve and protect the existing HDPE liners, media, and sprinkler systems to the existing biofilters.
- b) Contractor shall commence WORK of the Contract in July 2017 and complete said WORK by October 31, 2017.

DESCRIPTION OF WORK: The project consists of the following Items:

- a) Media Supply, Handling, and Placement into Biofilters: The general goals of the media handling and installation testing are to remove most of the fine material for later use and to distribute the larger, uniformly sized media into the biofilter cells via conveyor. Virgin bark shall be screened on a trommel screen and then placed in a manner that protects the screened bark from further damage or breakage.
- b) Cleanup and Removal: All unused material, both screened and unscreened will be removed from the OWNER's facility. Roadways shall be swept and restored, landscape shall be protected and not utilized. Any debris from construction shall be removed and disposed of by the CONTRACTOR.

SITE OF WORK: The site of the WORK is located at the OWNER's water reclamation facility at 7495 South 1300 West, West Jordan, Utah.

OBTAINING CONTRACT DOCUMENTS: The Contract Documents are entitled "South Valley Water Reclamation Facility – 2017 Biofilter Bark Addition".

The Contract Documents may be obtained by bidders, subcontractors and equipment suppliers at the website of the South Valley Water Reclamation Facility, 7495 South 1300 West, West Jordan, Utah 84084. The website address is [www.svwater.com](http://www.svwater.com).

BID SECURITY: Each Bid shall be accompanied by a certified check or cashier's check or Bid Bond in the amount of 10 percent of the Total Bid Price payable to the OWNER as a guarantee that the Bidder, if its Bid is accepted, will promptly execute the Agreement. A bid shall not be considered unless one of the forms of Bidder's security is enclosed with it.

**BIDS TO REMAIN OPEN:** The Bidder shall guarantee the Total Bid Price for a period of 30 calendar days from the date of bid opening.

**MANDATORY PRE-BID VISIT TO WORK SITE:** Prospective bidders are required to attend a pre-bid walk through of the proposed work site which will be conducted by the OWNER at 3:00 PM until 3:30 PM on June 15, 2017. The object of the walk through is to acquaint bidders with the site conditions. The pre-bid visit will start at the office of the OWNER located at 7495 South 1300 West, West Jordan, Utah.

**PROJECT ADMINISTRATION:** Technical communications relative to this WORK shall be directed to the OWNER prior to opening of the Bids. Communications relative to the purchase of Bid Documents shall be directed to the OWNER.
