This procurement involves the purchase of an ESSCO submersible pump with a 100% recessed vortex style impeller to replace one of an existing pair of pumps currently in service. If, for any reason, any party does not agree that this sole source purchase is applicable, they should contact the Issuing Procurement Unit Contact person listed above.

It is the intent of this sole source procurement to meet the following equipment specifications:

The pump motor shall be FM or UL listed, 25 HP, 1170 RPM, 460VAC, 3-phase, 60 hertz, service factor 1.15 at 4300-ft ASL, 250TY frame, submersible service with Buna-N O-rings and Carbon/Ceramic upper mechanical seal and Silicon Carbide lower mechanical seal, 416SS shaft, Class F insulation, oil buffer zone, built in thermal overload protection, dedicated 25-ft motor power lead, dedicated 25-ft control cable lead, clamped bell mouths strain reliefs on potted power and control cables, dual lifting rings, and moisture sensing probe installed, factory coated for submersion service. The pump shall be ESSCO model 4x16-25-6, Cool Agivents, constructed of High Chrome Iron 650 Brinnell, capacity 400 GPM at 65-ft TDH, capable of passing 4" diameter object, and backed by manufacturer's five year warranty on parts.

This sole source procurement is appropriate for the following reasons: 1) The procurement is a continuation of previous purchases and a clear potential economic benefit exists, 2) The procurement is done due to consideration of standardization / compatibility with existing equipment, parts and service, and 3) Transitional costs are unreasonable or cost prohibitive.

The final decision for this sole source procurement will be made no earlier and no later than August 8, 2018 at 2 PM.
